

#### 9 REPORTS

#### 9.1 ŌMOKOROA COMMUNITY BOARD CHAIRPERSON'S REPORT - APRIL 2022

#### **RECOMMENDATION**

That the Chairpersons report dated 5 April 2022 titled 'Ōmokoroa Community Board Chairperson's Report – April 2022', be received.

The Board met at the Community Board workshop on 11 March 2022, with the Roading Engineer (West) in attendance.

#### **Roadworks**

The roadworks continue to disrupt Ōmokoroa. Currently, J Swap is working on the road from Anderley Avenue to the roundabout at Tralee and Margaret Place. There have been some concerns about the organisation of the stop-go at times, as it can be chaotic and appear more disruptive than necessary. The Roading Engineer (West) agreed to investigate this.

#### Staff Comment:

Stop/Go operations are manged by qualified traffic controllers who control traffic flow to suit the type of road activity on any day and ensuring safety of all road users. Council fully understands the disruption and inconvenience this project is causing to the public and motorists. COVID-19 is also having a significant impact on the completion of this project. Notwithstanding the above, both Council and the contractor is doing everything possible to get the road sealed by March and completed by the end of May 2022.

I am aware that there have been concerns for Margaret Place/Drive residents about how people are using it as a detour and the diving skills utilised. This road often will have families walking with small children and strollers. While the residents understand the need for the detour, they're concerned about the speed and state of driving.

#### **Western Avenue Urbanisation**

Western Avenue urbanisation has begun, installation of concrete for the outline of the car parks and the provision for the lighting is now in place. Also, the structure of the concrete curbing.



I see that the walkway /cycleway ends at the cul-de-sac, the original end of Western Avenue. The question is, what are (if any) the plans as we advance regarding urbanisation to connect up with the whole of Western Avenue.

#### Staff Comment:

The piece of the footpath/cycle path is realigned at the cul-de-sac and connected to the new pedestrian/cycle path to make it safer for the road users.



#### Fires Station car parking

As a Board, we understand that the fire station car parking will be completed once the fire station's roading is finalised; it has been added to the J Swaps itinerary.

#### **Old Pavilion**

The Old Pavilion remains at its original site. Plans and building permit processes are currently underway. The estimated timeline for relocation is early May, with renovations over May, June, July.

As with all things at the moment, progress is subject to supply chain and COVID-19 variables.

#### COVID-19

COVID-19 continues to dominate our landscape and affect our whole way of being. It continues to affect the supply chain, the staffing levels at all levels of society, and local children's schooling. I am aware that everyone is doing the best they can within the powers that they hold. Hopefully, once these last surges of cases subside, we will begin to see the new normal settle into place, be that a lot more Zoom meeting for everyone's future.

#### Cycleway

An update on the connection from Josephine Place to the broad walk has been requested from the members of the public.

Staff Comment:

No construction has been undertaken to date. This route is part of our cycleways contractor work programme – we will get this during the year once works are completed at other sites.

#### **Cooney reserve**

The new toilet block is due for construction at the beginning of September 2022. Picnic tables have been ordered and are likely to be installed by June 2022. As this is the Council's preferred start to the cycleway, ideally, there should be some draw cards to ensure this. A BBQ possibility? The ones at the skate park have been successful to date. Staff Comment:

The Board could request a draft concept plan for Cooney Reserve to be developed – to include such items for wider consultation, capture budget and avoid unexpected consequences.

#### Cycle racks

Cooney Reserve racks have been purchased and are awaiting delivery

Esplanade cycle racks have been delivered and are in storage. They will be installed when the barbeques go in. There are few delays with resources being a little scarce with COVID-19.

It is expected the racks will be installed end of April 2022 by the latest.

#### **Developments and Bridges**

The Development has begun between Western Avenue and Kaylene Place



It is understood that the Kaimai Views Development is working with the Council and Kiwi Rail to construct a bridge over the railway from Tui Glen to Kaimai Views to counite the connection from Kaylene Place.

The Board asks that a bridge connecting Lynley Park to the Goldstone development be considered and or escalated. The bridges will help link both developments.

#### Staff Comment:

This project is currently scheduled in the Annual Plan for design and construction in 2026/2027. The Board can make a submission in the next Annual Plan Review if they wish to bring this project forward.

#### **Community Groups**

#### <u> Ōmokoroa Public Arts group (OPAG) - Member Teresa Sage</u>

The installation of the Godwits sculpture occurred. Due to COVID-19 and unveiling for the public, this is not happening under the current alter setting. The Group are looking at a low-key event and supplying photos for the Lizard News. The picture below does not do it justice as each Godwit moves around in the wind. This sculpture even survived the horrendous winds we had last month.



The changing shed mural at the domain has been completed and looks terrific.

Expression of interest has gone out to the public for artists to put their brief in for the Library mural using the Black Walnut log stored with Council.

### <u>Ōmokoroa Sports and Recreation Society (OSRS)- Member Peter Presland</u>

Business as usual with the use of the pavilion remains well utilised.

#### <u> Ōmokoroa Settlers Hall (OSH) – Member Derek Sage</u>

The Committee are trying to future proof their web presence. They have made the decision to defer the planned small hall renovations. The Committee agreed that there needs to be another toilet for people with disabilities

Ongoing communications with Council about the compliance schedule are in progress and the committee are working on finer detail to satisfy the process.

#### **RECOMMENDATION**

#### **BACKGROUND**

#### Kerbside changes due to COVID-19

- Neither the food scraps bin or glass crate will be collected until further notice
  after several of Council's Kerbside Collective drivers either contracted the virus or
  are household contacts and are following Ministry of Health advice to selfisolate.
- The reduced service still allows the community to use their yellow lid recycling bin and red lid rubbish bin.
- There is also a change in hours for the Athenree and Katikati recycling centres until further notice. Katikati: Thurs (9am-4pm), Sat (1pm-4pm), Sun (Closed).

#### **Annual Plan**

- Council will consult on the Annual Plan 2022/23 from Monday 21 March to Thursday 21 April.
- The Annual Plan 2022/23 rates increase is 3.96 percent, marginally lower than the 3.98 percent signalled for 2022/23 in the Long Term Plan 2021-31.
- Given the Long Term Plan was adopted just last year (2021), there are no big changes to what we agreed with the community through the process.
- The only consultation item will be on the future of the Pukehina Development Rate. Why? For 21 years we have been collecting funds towards a Pukehina wastewater scheme, but given the uncertainty around how Central Government's Three Waters Reform Programme would affect this fund, we want your opinion on what the future of this rate should be – should we continue, pause, stop or repurpose the Pukehina Development Rate?
- Feedback can be provided online via haveyoursay.westermbay.govt.nz/annualplan2022, at Council's in-person feedback session on Saturday 2 April from 10am-2pm at the Pukehina Fishing Club, or via feedback postcard.

#### **District Plan Review**

- Council will begin the conversation with our communities on the District Plan Review starting in April.
- The District Plan, which touches on many aspects of how people can use their land and our communities Western Bay way of life. It includes everything from earthworks to open spaces. These plans have to be reviewed every 10 years and take several years to complete.
- These community conversations will also inform our response to legislation changes as opportunities arise. It is important our communities know change is coming and they can influence/shape planning changes via this 12 to 18-month District Plan Review.
- The first topic we will be highlighting will be Housing and Place Management and Localism. This will enable us to begin conversations with both the Te Puke and Ōmokoroa communities in particular about the new housing provisions from the Resource Management (Enabling Housing Supply and Other Matters)
   Amendment Act 2021.

#### Infrastructure Acceleration Fund

- Council has put forward a proposal to the Kāinga Ora-managed Infrastructure Acceleration Fund (IAF) to create an interim solution to the safety and capacity issues at the State Highway 2 Ōmokoroa intersection.
- The proposal is seen as a 10-year solution until funding is available to build a full interchange.
- Council has submitted a \$40 million proposal for the State Highway 2 / Ōmokoroa Intersection.
- If the concept, worth roughly \$40 million, gains approval we will work with Waka Kotahi to further develop the design.
- We expect to hear the outcome of this stage of the application process in April 2022.

#### **Three Waters reform**

- The Government has announced it will make its Three Waters reform mandatory
  for all councils, rejecting the option to make it voluntary for councils. The reform
  will see the management of drinking water, wastewater and stormwater
  transferred from 67 councils to four public-owned entities.
- Council in late 2021 consulted with the community on the Government's proposed arrangements for Governance, Accountability and Representation of the new entities.
- All feedback has been collated and summarised, and provided to Government's working group, which reported back to Government in March 2022.
- In December 2021 Minister Nanaia Mahuta announced Government will be delaying the Water Service Entities Bill until after the working group's report.
- Council staff spent February identifying risks and opportunities that may arise during the transition, and prioritise the actions required. A project plan, organised

by various workstreams, is now being populated with recommended actions for 0-3 months and 3-6 months.

#### Council at RED and Omicron Phase Three

- At Red Council is enforcing the use of My Vaccine Passes as a condition of entry
  at its facilities for people aged 12 years and older. Facilities include, all library and
  service centres, swimming pools and the TECT Park arrival area.
- Council will continue to run community engagement events in a safe and practical environment, but other celebratory events will be cancelled.
- The decision has been made due to the risk of Omicron in the community and doing what we can to limit the spread of the virus.
- We appreciate this is a shift from Council's system at Orange but we believe this
  is the safest option. Alongside this we are offering a click and collect service at
  our library and service centres for anyone unvaccinated.
- Council has mandated vaccination for all staff as the safety and wellbeing of our people and the communities we serve is critical, and vaccinations are the most effective way of keeping us all safe from COVID-19.
- All contractors and service providers must be fully vaccinated when interacting with our staff at our offices and facilities outside of public meeting areas.
- Council staff are encouraged to work from home, where practically possible, to
  ensure business continuity. Like numerous organisations nationwide, we are
  experiencing a number of COVID cases with staff and are adjusting our levels of
  service accordingly.

#### Council and Community Board meetings at RED

- Upcoming Council, community board and ward forum meetings will now take place virtually via Zoom to help slow the spread of COVID-19 in the community.
- The decision to go online affects all meetings including Council and its committees, community boards and ward forums, and it means everyone including elected members, community and media will need to attend virtually until further notice.

This report provides specific information on Infrastructure activities of interest to the Board.

#### RECOMMENDATION

#### **ROADING**

#### Transportation - Ōmokoroa Community Roading

Description: Develop and implement the community roading plan approved by the Ōmokoroa Community Board.

The proposed Fire Station Hard Standing parking area has been cost estimated by WestLink. Staff are currently investigating options to add this project as a variation to the Ōmokoroa Urbanisation Project but will be still funded by the Board.

Two cycle maintenance stations have been proposed, to be located at the beginning of the Ōmokoroa Cycleway link and Ōmokoroa Point School. Both locations are yet to be confirmed.

#### Transportation - Road Improvements LED Lighting

Description: Council owns and operates 2,500 streetlights on local roads. Close to 100 of these are LED. Installation of LED lights reduces power consumption by 60%. Cost reduction is on the energy charges as line charges are a fixed fee. Waka Kotahi are offering an 85% subsidy to invest in the street light conversion conditional upon it being completed by June 2021. Council has decided to participate in this.

#### What's Happened:

Works to install LED luminaires in the west and east sections of the District is complete.

#### What's Next:

There has been no change to this item since the previous update due to the delay of material supply for the upgrading of decorative lighting, mainly recent subdivisions, still being an issue and is likely to commence early 2022.

Specific lighting design, which is required for "V" category lighting on high volume roads, such as Te Puke Highway and Ōmokoroa Road, will be considered once the installation of decorative lighting is complete.

The majority of outstanding materials have been delivered. WestLink are currently:

- Manufacturing fittings that allow new LED luminaires to be fitted to existing columns, and
- Developing a programme for the remaining installations which is anticipated to commence early April.

#### **UTILITIES**

#### **Western Solid Waste**

Description: Waste management that meets the needs of the community and protects the environment for present and future generations.

#### What's Happened:

Kerbside Collection tonnage continues to grow. Plans are being put in place to help navigate through the COVID-19 Omicron outbreak.

Neither the food scraps bin or glass crate will be collected from the following dates after several of Western Bay of Plenty District Council's Kerbside Collective drivers either contracted the virus or are close contacts and are following Ministry of Health advice to self-isolate.

#### What's Next:

Investigations are underway to further add new properties throughout the District.

#### Changes to kerbside collections due to Covid implications

- Food scraps will not be collected from Thursday 3 March for a number of weeks
- Glass crate will not be collected from Monday 7 March for a number of weeks

#### **RESERVES**

#### Reserves - Ōmokoroa Domain

Description: Implement the approved Domain Concept Plan including the destination playground.

#### What's Happened:

Domain playground construction is complete and being well used. Public feedback has been very positive.

#### What's Next:

Install BBQ near playground – this is expected to be constructed in March.

Conclude the foreshore design to Crapp Reserve for implementing post summer holiday season. Due to Covid-19 disruptions, instead of a formal opening, a public celebration has been proposed to occur on its first anniversary (December 2022).

# Reserves – Prole Road to Pahoia Walkway/Cycleway

Description: Construction of a cycleway suspension bridge across the Waipapa Stream.

#### What's Happened:

The bridge construction is now complete.

 Landscape planting on the Ōmokoroa side has been completed (resource consent condition).

#### What's Next:

- Conclude legal agreements with affected property owners to ensure public access is secured across private land both sides of the Waipapa Stream.
- Progress cycleway lease agreement with KiwiRail.
- Complete construction of cycleway at both ends of the bridge to connect to road network. This includes trail surfacing, fencing, planting and a safe exit onto Pahoia Road. The route is expected to be open by the end of June

### **ENGINEERING / SPECIAL PROJECTS**

#### Prole Road Urbanisation – Ōmokoroa Road to Waipapa River

Description: Prole Road is part of the Crown Infrastructure Partnership programme and partly funded by the Government.

#### What's Happened:

The design of Prole Road urbanisation from Ōmokoroa Road to the Waipapa River is still continuing. The project is running behind schedule due to ongoing discussions with the landowners and developers and resource consenting issues. Since the instigation of this project, several developers have bought large amounts of properties adjacent to Prole Road and are now planning to subdivide their land at the same time as Prole Road is being upgraded. This is requiring Council to make a number of changes to roading and other infrastructure to accommodate the subdivision requirements. This is causing further delays to the final design and construction of Prole Road.

#### What's Next:

Continue discussing with the adjacent landowners and land developers and finalise design of the project. Consult other affected stakeholders, get the necessary consents, and finalise contract documents for tendering the construction work. Construction work is anticipated to commence next construction season once the design, landowner and consenting issues are finalised.

#### Western Avenue Urbanisation – Ōmokoroa Road to North of Gane Place

Description: Urbanisation of Western Avenue as a CIP and Structure Plan Project. The works integrates some planned reserve development example footpaths and cycleways on adjacent Council reserves.

#### What's Happened:

Council has engaged J Swap contractors to construct this project. Construction work is progressing well and expected to be completed by June 2022.

#### What's Next:

Continue with construction work until completed by June 2022.

#### **New Southern Industrial Road**

Description: Ōmokoroa Industrial Road design and construction including right turn bay on Ōmokoroa Road.

#### What's Happened:

The design for the Southern Industrial Road is complete and tender document is being finalised. Council has obtained Archaeological Authority from NZ Heritage and is now waiting for the earthworks consent from the Bay of Plenty Regional Council. Council will tender this project for construction work once earthworks consent is obtained from the Bay of Plenty Regional Council.

While this process is happening, Council is investigating options for constructing a permanent stormwater pond at the start of the existing gully to treat the runoff from the Industrial Road and the upper catchments areas.

#### What's Next:

Obtain earthworks consent from the Regional Council for earthworks and invite tenders for the construction of the Industrial Road.

#### Ōmokoroa Road Urbanisation Stage 1 - Western Avenue to Tralee Street

*Description*: Ōmokoroa Urbanisation Project - Western Avenue to Tralee Street including services, walking, and cycling and bus stops.

#### What's Happened:

The project is under construction and the contractor is making an excellent progress. There has been slight delay in the construction due to Covid shutdown however, the target date for the project is still June 2022.

#### What's Next:

Complete the works by June 2022.

#### Ōmokoroa Road Urbanisation Stage 2 - Prole Road to Railway Track

*Description*: Ōmokoroa Urbanisation Project from Prole Road to the railway line. Includes two roundabouts and four-laning from Prole Road to Flounder Place.

#### What's Happened:

The design for this section has been extended to include 4 lanes from Prole Rd/Ōmokoroa Road intersection to Flounder Drive intersection to allow for the future JACE town centre development.

Council is currently working with both the Ministry of Education and JACE Development to come up with an effective design which will cater for both the MOE and JACE town centre in the future years. The work includes the redesigning of the section from Prole Road to Flounder Drive to make it 2 lanes in each direction to serve the community over the next 20 years.

#### What's Next:

Complete the redesign of this project and appoint a contractor to start the construction work when the design is finalised.

#### Ōmokoroa Road Pedestrian Bridges

Description: Ōmokoroa Road Urbanisation Project. Construction of two pedestrian bridges over the railway and walking connections. This project is practically complete and only minor works are remaining to be during the defect's liability period.

Both the pedestrian/cycle bridges are practically complete and minor works e.g., retaining wall, topsoil and hydro-seeding remain to be competed over the defect's liability period.

#### What's Next:

Complete minor works by end of June 2022.

#### STRATEGIC PROPERTY

#### Property - Development Town Centre Ōmokoroa

Description: Omokoroa Town Centre Development in accordance with direction as resolved by the Community Board - McDonnell Street property purchase and pavilion relocation.

#### What's Happened:

The leases for both the old Library and the MenzShed have been signed. Planning is underway for the relocation of the Old Sports Pavilion and its subsequent refurbishment.

Planning and geotechnical work will be completed for the relocation of the Old Sports Pavilion.

#### What's Next:

Planning and geotechnical work will be finalised with a view to moving the old Pavilion closer to Western Avenue. Staff will then seek quotes to undertake remedial work to the old Pavilion, including the construction of toilet facilities.

#### **EMERGENCY MANAGEMENT**

Description: Support the Ōmokoroa Community to be resilient in the event of an Emergency.

#### What's Happened:

Maintained communication with weather update prior to Cyclone Cody and sent out communications in regard to Covid preparedness updates.

#### What's Next:

Staff will continue to work and engage with the community to ensure positive outcomes going forward with the possible development of a Community Response Team.

Mr Farrell noted the condition of the footpaths around the urban area of Kaimai Views. He questioned the Levels of Service for these areas and sought clarification from Council regarding what could be done to address this issue moving forward.

Council staff noted that work to address the noxious plants surrounding the footpath areas would be referred to WestLink for immediate spraying. Council would be undertaking a review of the plants specifically chosen for the berm area in the New Year.

The Noxious plants within the gardens and growing close to footpaths have now been removed.
