- To have input into Council and its Committees on issues and plans that affect communities within the Community Board area.

#### David Rolfe - Ōmokoroa Bowling Club

Mr Rolfe was in attendance to speak on behalf of the Ōmokoroa Bowling Club, providing the Board with the background, rationale and overall objective sought through the Grant application. In order to ensure that the artificial green complies with world standards, the Ōmokoroa Bowling Club will be engaging a specialist project manager. It was noted that this is what the funds being sought would contribute to.

Councillor Grainger sought clarification as to whether the Ōmokoroa Bowling Club was on Council land, and if so, if this meant the Board could look at funding this through the Community Board Reserve Account.

There was some discussion around Council's Level of Service in relation to projects like this, however because it was a specific non-recurring project on Council land, it was believed that this would fit the criteria.

It was agreed that further discussion on this Grant application would occur, alongside the report later in the agenda.

#### Ben Wilson – WBOPDC Community Resilience Advisor

Mr Wilson was in attendance to introduce himself, and his role, to the Community Board and members of the community, noting the below points:

- Mr Wilson formerly worked within Council's Community Team for 25 years;
- His current role was created to help support communities with the development and review of the Community Response Plans and to support Community Response Teams; and
- All communities will still have support from Emergency Management Bay of Plenty (EMBOP).

#### Matthew Farrell - Possible options for the old Sports Pavilion Building

Mr Farrell was in attendance to speak to the Board on his proposal for the Old Sports Pavilion, noting that there would be a meeting on Wednesday 9 June to see if there was any traction for a steering group to be established to pursue this proposal. A letter to the Board was circulated prior to the meeting.

The Chairperson noted that she would get in touch with Mr Farrell, following the meeting, to clarify next steps.

Councillor Grainger commended and thanked Mr Farrell for the work he had completed so far.

#### His Worship the Mayor - Takitimu Northern Link (TNL) Update

His Worship the Mayor was in attendance to provide both the Board and members of the public with some background to the recent announcement regarding the Takitimu Northern Link, noting the below points;

- Stage 1 between Tauranga and Te Puna is fully funded and will commence in late 2021; and
- There was a Regional Land Transport meeting scheduled for Wednesday 9 June 2021, to determine the priorities for the region. His Worship the Mayor noted that he would be advocating on behalf of the Ōmokoroa residents, for the Ōmokoroa Intersection/Interchange to be upgraded as a high priority, advising the Board that this would sit separately to the Takitimu Northern Link project.

#### **Omokoroa Public Arts Group**

Member Evans provided the Board with an update, noting that artist, Dave Roy, had been appointed for the Godwits sculpture, with an estimated completion date of October 2021.

The Board was also advised that the Ōmokoroa Public Arts Group is looking for new members.

#### Local Government New Zealand (LGNZ) Conference

The Chairperson made a presentation to the Board regarding the 13<sup>th</sup> Local Government New Zealand Conference held 22-24 April 2021 in Gore. The following points were highlighted:

- How the Community Board can identify the needs of the community and align their goals to the 17 United Nations (UN) global goals.
- Connecting communities to enhance the social, environmental, cultural and economic wellbeing how can the Community Board provide a safe community for Ōmokoroa so it can thrive?
- A particular goal that came out of the conference for the Chairperson, was improving on the work undertaken to engage with local iwi.

- Sustainability of our world to ensure that our ecological footprint is not destroying our environment.
- Seeing the impact that COVID-19 has had on small businesses, highlighting the importance of encouraging the people in Ōmokoroa to support local.
- Gore vs Ōmokoroa, noting the below points:
  - The population of Gore in 2020 was 12,900 and Ōmokoroa is estimated to grow to 12,000; and
  - Gore has its own museum, an established town centre, and both a community centre and community civic centre in the pipeline. It was noted that all of these could be goals for Ōmokoroa.

It was noted, however, that the Board could fund specific capital non-recurring projects for Council assets on Council land from their Reserve Account as part of their delegated functions. The point in question was around whether this was for a 'Council asset' or not.

The Board also had a discussion around whether or not the same project could be funded through two different Council sources over separate financial years, as the Community Board did not want to disqualify the Ōmokoroa Bowling Club from their application to the Community Matching Fund.

#### 9.1 OMOKOROA COMMUNITY BOARD CHAIRPERSONS REPORT - AUGUST 2021

#### **Ōmokoroa Bridges**

The new bridges over the railway line are now able to be used by the public. They look impressive, and a comment from one member of the public is that they look better than the original existing road bridge - I must agree.

#### **Ömokoroa MenzShed**

The MenzShed have shown an expression of interest in the buildings on the corner of Prole and Ōmokoroa Roads. The Ōmokoroa Community Board support this expression of interest and are aware that there will be procedures for council and MenzShed to undertake for this to happen.

We look forward to the MenzShed being able to start their projects. I am aware that there is a lot of interest in the community with upcoming wish lists.

#### **Skate Park**

There has been communication from the public requesting cameras overseeing the skate park.

I am aware of reports of children being assaulted at the skate park by other older youths and that children are now scared to go there and play. This was not what the skate park was intended for, all children should be able to feel safe in their community.

The question is, how we can keep our children safe?

#### **New Bins**

The new bins system arrived in Ōmokoroa, as it did throughout the district. I know that there have been teething problems and hopefully these will be ironed out quickly.

#### More seating in Ōmokoroa

Counsellor Grainger is currently investigating the possibility of more seating for around the peninsula.

#### Communication – Ōmokoroa Bowling Club

#### **Community Groups**

Omokoroa Community Policing Group and Charitable Trust (OCPGCT) – Member Teresa Sage

Senior Constable James Muir gave an update on several recent incidents that had happened in Ōmokoroa and noted that he was in the process of resolving the issues. He reported that groups of troublesome youths were causing damage to building sites and passing cars, and they were creating disturbances at the skate park and Western Avenue reserve. There was a concern from the OCPGCT group that when a major incident happens on State Highway 2 the police are not able to attend to crime here in Ōmokoroa.

Senior Constable Muir was able to say that there are always Police traffic patrols on State Highway 2 (SH2), and they could be diverted to Ōmokoroa incidents if, the patroller deemed it appropriate.

#### Neighbourhood Support Report:

The coordinator of the neighbourhood support group, Cathy, resigned at the Annual General Meeting (AGM) 21 July 2021, and a new coordinator will be required.

#### Patrol Report:

There continues to be crime reported in Ōmokoroa. This ranges from reported missing dogs, attempted break ins, theft, burglary, breaking and entering vandalism, and boy racers.

#### Training:

Police training took place on 25 May 2021 and 26 June 2021, where there were 15 attendees from the patrol.

Community Patrols of New Zealand (CPNZ):

A new code of conduct is required to be signed by all existing patrollers, including a driving licence check.

Police attendance at The Old Library Ōmokoroa (TOLO):

Senior Police Constable, James Muir, will be at The Old Library on Tuesdays and Fridays 12.00-14.00 - this is subject to operations requirements.

#### Funding:

The group continues to apply for funding from various organisations for their operational existence. OCPGCT has been advised that there may be a change of Community Board representation going forward - this will be confirmed at next Community Board Meeting.

#### Ōmokoroa Sport and Recreation Society (OSRS) - Member Peter Presland

#### **Booking Officers Report:**

Sarah advised the 'Friendly Manager' site for managing bookings, payments and contact with hirers is working really well. She is also able to store and access the document required for bookings electronically. Good reviews have been received from users of the Pavilion.

#### Treasurers Report:

Dennis advised the Society has opened a new Bank account with ANZ following the decision at the previous meeting. He has moved most of the Society's funds to the new account leaving enough funds in the SBS account to cover any automatic payments pending. Once these are updated all monies will be with ANZ. Dennis advised that ANZ provides much better access to reports, documents and statements.

#### Other Matters:

A draft of a Hazard Register for the Pavilion was presented, with a couple of amendments suggested, these will be added for Secretary Andrea to finalise. The register will be stored in the folder in the kitchen at the Pavilion. Two 'Wet Floor' signs will be purchased to be used when floors are washed or any spills occur.

Events planned for the next year are a Comedy Show with Ben Hurley and others in February 2022, another Outdoor Concert in March with the Concert Committee currently working on this. A proposal for a Christmas in the Park is being considered.

There has also been an application for funding completed for The Centre, for the planned Children's Party.

A draft of the new sign was presented from Steve Roach of Letter Rip Signs. A few amendments were suggested. Andrea to liaise with Steve. Money has been set aside for this and once completed, it will replace the Thermometer Sign by the Skate Path.

As the Website is up and running, user groups are asked to provide a short piece of information with contact details of their activity/group, which can be uploaded to the Website for members of the community to see what is available at the Pavilion. Please send this information to the Secretary by email or via the email on the Website.

#### Settlers Hall Report - Member Derek Sage

There is a problem with the kitchen add-on to the small hall. There is borer in the bearer under the floor, which should be fine for a time; however, it is preferable to deal with it before it fails and there is a crisis.

At this stage, the committee is thinking that the best way to proceed is to demolish and replace the existing small hall extension. However, the end decision will obviously depend on Council consents,

costs and any other issues, which could arise. However, to begin with employing someone to draw up a building plan seems to be the best way forward. This would establish potential costs including any for consents from council.

#### Omokoroa Public Arts Group (OPAG) - Member Teresa Sage

Dave Roy has been given the initial payment for the Godwits sculpture and on completion of the project he will receive the remainder of the payment.

The group are still in discussions regarding the mural at the domain and a large peninsula map for TOLO display.

The OPAG are looking at modifying their summary for the Omokoroa website.

OPAG have been advised that there will be a change of Board representation, which will be confirmed at the next Community Board meeting.

#### Omokoroa Environmental Managers Inc. (OEMI) Report - Councillor Murray Grainger

It has been a busy time arranging the lease with Council for the Old Library premises. A condition of the lease was to hold Broadform Liability (formerly known as Public Liability) insurance and this proved to be a bit of a challenge but one which was eventually overcome.

The operation of the TOLO Member Operating Group is proving to be a great success with the community and, even without significant promotion, visitor numbers continue to climb and are now well over 400 per month. Through the pop-up phase, displays were held featuring:

- Ōmokoroa Environmental Managers Inc. Birdlife and Habitat Protection and Pest Free
- Ōmokoroa History Group The Changing Face of Ōmokoroa
- Hands Up for Tools local amateur artisans
- Ōmokoroa Artists Colour My World
- FOCUS the Art of Photography
- Ōmokoroa Community Garden Growing Strong (with free produce)
- Ōmokoroa Public Art Group Projects Past, Present and Future
- ANZAC Lest We Forget
- Keeping Us Safe Ōmokoroa volunteers dedicated to protecting our homes and personal safety
- · Quilting group, Pencil Art and others.

The space is used for others as well, including:

- Knitters' Group;
- Alzheimer Support Group;
- Community Constable;
- Local MP; and
- A 'drop in and chat' space.

#### RECOMMENDATION

#### **BACKGROUND**

#### **New CEO**

Welcome to our new CEO, John Holyoake. John comes into office with "change" being "one of the constants" on the horizon (Three Waters, Local Government Review).

#### Long term plan (LTP)

The LTP was adopted at the Council meeting held 29 June 2021. It outlines a ten-year budget with a 'one off' rise in Council rate income of just under 12% for this financial year (including the introduction of rate funded recycling and food scrap collection) and a budgeted increase of less than 4% increase for the subsequent nine years.

#### **Ömokoroa Stage Three**

Three consultation meetings have been held in the community since the last board meeting. From the feedback collected, Councils Policy Committee has recommended to Council that option 1 (corner of Ōmokoroa & Prole Road) be the preferred site for additional recreation fields for the community.

A 'streamlined' process was also supported to apply to the minister for after the next 12 months of work to allow the plan to become operative faster.

The Committee was informed that the Ministry of Education was working toward the development of a new primary school, as well as secondary school on the Ministry of Education land they have purchased (Years 0 - 13)

#### **Three Waters Reform**

The detail of this water reform is slowly starting to emerge. Council will pass on information as decisions are made.

#### **SmartGrowth**

An end of an era for the current 'SmartGrowth Subregion Growth Strategy' with the retirement of key consultant, Ken Tremaine, and long standing chair, Bill Wasley. Both have been instrumental in dealing with Wellington political changes over the years.

#### Kaimai Ward Forum / Council - Community Consultation.

The last Kaimai Ward Forum heard a summary to date of the "Three Waters Reform" by panel member / outgoing CEO, Miriam Taris. In addition, the plight of the Ōmokoroa intersection was raised. This is the first term of the Forums (outside of Community Boards). All options for improvement between the community (residents and ratepayers) and Council are always under review and a formal review of representation will be held after next years elections.

#### **Ōmokoroa Pedestrian Bridges**

It is great to see that the new pedestrian bridges over the railway are almost complete. To remove this safety hazard is a long-awaited result.

#### **EXECUTIVE SUMMARY**

1. This report provides an update on the status of the commitment made by the Ōmokoroa Community Board in July 2018 to fund park bench style seats on various local reserves on the peninsula. The initiative has delivered 13 new seats at a cost (to the board) of \$8,434. The project is now complete.

#### RECOMMENDATION

- 1. That the Customer Services and Governance Manager's report dated 3 August 2021, titled 'Update Ōmokoroa Community Board Public Seating Project', be received.
- 2. That the report relates to an issue that is considered to be of low significance in terms of Council's Significance and Engagement Policy.

#### **BACKGROUND**

In response to requests from the community, the Ōmokoroa Community Board passed the following resolution at their July 2018 meeting:

THAT the Ōmokoroa Community Board allocate funding up to \$10,000 from the Ōmokoroa Community Board Reserves Account for the future construction and placement of recycled plastic or wood seating at various sites throughout the peninsula.

The intention of the resolution was to allow members of the community to donate a contribution towards a seat and the remainder of the cost would be met via the board's funding of up to \$10,000.

The project was coordinated by the Ōmokoroa Environment Management Incorporated Society (OEMI) and they collected the donations on behalf of the Community Board.

Council's Reserves and Facilities staff have coordinated the manufacture and installation of 13 seats which have been paid for from Reserves and Facilities budget.

Council has now invoiced the OEMI for the total contributions received and held on behalf of the community.

The OEMI Group arranged individual plaques to recognise contributions made by community members. This cost is part of the total cost of installation.

A Financial Statement has been prepared to show the total expenditure of the project.

The proposed Fire Station Hard Standing parking area has been cost estimated by WestLink. Staff are currently investigating options to add this project as a variation to the Ōmokoroa Urbanisation Project but will be still funded by the Board.

Two cycle maintenance stations have been proposed, to be located at the beginning of the Ōmokoroa Cycleway link and Ōmokoroa Point School. Both locations are yet to be confirmed.

#### **Transportation - Road Improvements LED Lighting**

Description: Council owns and operates 2,500 streetlights on local roads. Close to 100 of these are LED. Installation of LED lights reduces power consumption by 60%. Cost reduction is on the energy charges as line charges are a fixed fee. Waka Kotahi are offering an 85% subsidy to invest in the street light conversion conditional upon it being completed by June 2021. Council has decided to participate in this.

#### What's Happened:

Works to install LED luminaires in the west and east sections of the District is complete.

#### What's Next:

Upgrading of decorative lighting, mainly recent subdivisions, has been delayed by material supply issues and is likely to commence early 2022.

Specific lighting design, which is required for "V" category lighting on high volume roads, such as Te Puke Highway and Ōmokoroa Road, will be considered once the installation of decorative lighting is complete.

#### **UTILITIES**

#### Western Solid Waste

Description: Waste management that meets the needs of the community and protects the environment for present and future generations.

#### What's Happened:

The new Council-led Kerbside Rubbish and Recycling Service started on 1 July 2021. A Pay as you throw (PAYT) user-pays tag system applies for rubbish collection. Collection of red lid rubbish bins will be available each week - bins need to be put out at 7am on collection day with a PAYT tag correctly attached through both the red handle and black lug.

Waste Management Ltd has stopped collecting pre-paid green rubbish bags on 30 June 2021 throughout the district. Bags presented at the kerbside will not be collected.

#### What's Next:

Customers can still take excess glass, cardboard and plastics #1 & #2 to the Council's Recycle Centres. Any leftover pre-paid green bags can be taken to our recycling centres for disposal. Bins to collect these green pre-paid bags will be there for July and August only and will be removed straight after.

If unsure of a collection day for the new service, residents can find their collection day printed on the side of their red lid rubbish bin or yellow lid recycling bin once delivered or use the online tool to see what bins to put out. For more information visit <a href="www.kerbside.co.nz/collection-day/">www.kerbside.co.nz/collection-day/</a>

PAYT tags are available for purchase at Council's service centres and selected outlets. For more information visit <a href="https://www.kerbsidecollective.co.nz">www.kerbsidecollective.co.nz</a>

The recycling bins for glass that were provided by Waste Management Ltd and paid by Council through the Waste Levy at the Fresh Choice supermarket in Ōmokoroa were removed at the end of June 2021. Glass can now be recycled fortnightly by residents at the kerb in Ōmokoroa in the 45 litre blue crate. Glass collection is part of the suite of kerbside rubbish and recycling services that commenced 1 July 2021.

#### **RESERVES**

#### Reserves - Ōmokoroa Domain

Description: Implement the approved Domain Concept Plan including the destination playground.

#### What's Happened:

The playground construction contract has been awarded to Downer.

#### What's Next:

Construction works are scheduled to begin mid August and completed by Christmas. Note there remains a small risk that further supply chain delays beyond those already known and allowed for may affect pre-Christmas 2021 delivery expectations.

#### Reserves - Ōmokoroa Stormwater Bund and Walkway/Cycleway

**Description**: Construction of a coastal bund shared path walkway along the esplanade reserve adjoining the Ōmokoroa golf club

#### What's Happened:

Stage 1 & 2 foreshore bund path construction has been completed, with just some minor drainage to complete.

New signage along the route has been installed advising walkers and cyclists to keep to the public pathway and not to wander onto or use the golf course as a shortcut.

Negotiations have been underway with the contractor to conclude methodology and price for the 80m timber boardwalk section "Stage 3" (for which resource consent has now been obtained). The main issue to resolve is how to deliver the timber materials to site given access across the golf course is not possible due to wet ground conditions. A helicopter is being considered but if it proves too expensive, then this stage of the project may have to wait until summer and ground conditions for transport vehicles are suitable.

#### What's Next:

Conclude methodology, pricing and timing for Stage 3 boardwalk construction.

If required, additional 'dogs on a leash' signs will be put along the pathway side of the new post and rail fence advising dog owners to keep their dog on a leash as required by the Dog Control Bylaw.

Complete Stage 4 upgraded path from Kaylene Place when stage 3 boardwalk completed. In the meantime, the vegetation along this route is being trimmed back to improve sight lines and access. An official opening with the Golf Club is planned for later in the year.

#### Reserves - Prole Road to Pahoia Walkway/Cycleway

Description: Construction of a cycleway suspension bridge across the Waipapa Stream

#### What's Happened:

Written approval for construction access across the Ngaati Hauaa property has been given, whilst a lease agreement is being worked through. Note that agreement remains subject to Ōmokoroa Structure Plan Stage 3 zoning commitments.

Bridge steelwork fabrication is well underway. The shipping container for trail user protection under the railway bridge has been obtained, modified, painted and delivered to site. Preliminary site works to clear vegetation and install the shipping container has started.

Whaka Kotahi has been invoiced the full amount for their agreed project funding of \$600k

#### What's Next:

Conclude the lease agreement with Ngaati Hauaa and complete the railway bridge shipping container under-pass installation in anticipation of the suspension bridge construction beginning in August.

Advance and conclude arrangements with the adjoining property owners at Pahoia to enable trail and bridge construction access (this involves temporary works).

#### **ENGINEERING / SPECIAL PROJECTS**

#### Prole Road Urbanisation - Ōmokoroa Road to Waipapa River

#### What's Happened:

The design of Prole Road urbanisation from Ōmokoroa Road to the Waipapa River is still being finalised. Unfortunately, the project is running behind schedule due ongoing discussions with the landowners, design and consenting issues.

Prole Road is part of the Crown Infrastructure Partnership programme and partly funded by the Government.

#### What's Next:

Continue finalising the design of the project and discuss with the adjacent landowners where the road design is impacting on their land. Secure the necessary consents and develop contract documents for inviting tenders for the physical construction work. Construction work is anticipated to commence once the design, landowner and consenting issues are finalised.

#### Western Avenue Urbanisation - Ōmokoroa Road to North of Gane Place

*Description:* Urbanisation of Western Avenue as a CIP and Structure Plan Project. The works integrate some planned reserve development example footpaths and cycleways on adjacent Council reserves.

#### What's Happened:

A meeting has been held with the adjacent landowners on the design of Western Avenue and investigation and design of the project is continuing. Council has appointed Westlink consultants to assist with the design of the project and significant design is expected to be completed by the end of July 2021. Public will have the opportunity to view the latest design on 29 July when Council will be updating the community on the on-going Ōmokoroa projects.

Once the detailed design is complete, construction will start in this summer and expected to be completed by June 2022.

#### What's Next:

Finalise the design, appoint a contractor and start construction work in Summer this year (2021).

#### **New Southern Industrial Road**

Description: Ōmokoroa Industrial Road design and construction including right turn bay on Ōmokoroa Road.

#### What's Happened:

The design for the Southern Industrial Road is complete and tender document is currently being prepared for seeking tenders for the construction work starting this summer.

#### What's Next:

Prepare contract document for inviting tenders for the construction work in summer this year (2021/2022).

#### **Ömokoroa Road Urbanisation Stage 1 - Western Avenue to Tralee Street**

Description: Ōmokoroa Urbanisation Project Urbanisation from Western Avenue to Tralee Street including services, walking and cycling and bus stops.

#### What's Happened:

The project is under construction and the contractor is making good progress. There has been slight delay in the construction of some retaining walls however, the project is still on schedule to be completed by June 2022.

#### What's Next:

Complete the works by June 2022.

#### Ömokoroa Road Urbanisation Stage 2 - Prole Road to Railway Track

Description: Ōmokoroa Urbanisation Project from Prole Road to the railway line. Includes two roundabouts and four-laning from Prole Road to Flounder Place.

#### What's Happened:

The design for this section has been extended to include 4 lanes from Prole Rd/Ōmokoroa Road intersection to Flounder Drive intersection to allow for the future JACE town centre development. Council is currently working with both the Ministry of Education and JACE Development to come up with an effective design which will cater for both the MOE and JACE town centre in the future years. The work includes the redesigning of the section from Prole Road to Flounder Drive to make it 2 lanes in each direction to serve the community over the next 20 years.

#### What's Next:

Complete the redesign of this project and appoint a contractor to start the construction work when the design is finalised.

#### **Ōmokoroa Road Pedestrian Bridges**

Description: Ōmokoroa Road Urbanisation Project. Construction of two pedestrian bridges over the railway and walking connections. The eastern bridge is stronger and could carry light vehicles in an emergency.

#### What's Happened:

Both the pedestrian/cycle bridges are almost complete and the contractor is currently completing the bride decks, guardrails and the approach footpaths. The other remaining work will be tidy up of the site, topsoil and hydro-seeding and completion of minor structural components of the bridges.

#### What's Next:

Complete the two new bridges by end of August 2021.

#### STRATEGIC PROPERTY

#### **Property - Development Town Centre Ōmokoroa**

Description: Ōmokoroa Town Centre Development in accordance with direction as resolved by the Community Board - McDonnell Street property purchase and pavilion relocation.

#### What's Happened:

The request for expressions of interest have been assessed by the Board. The Board have recommended to Council that the submission from TOLO for the old library be accepted, and that the submission from MenzShed lie on the table pending further discussion between the Board and MenzShed. Council have approved the Board recommendation and the Strategic Property Manager is working with MenzShed to find suitable accommodation for them.

#### What's Next:

The Strategic Property Manager and MenzShed are looking at alternative locations that may be suitable to use on an interim basis. Negotiations are in progress on the proposed MenzShed being located at the site on the corner of Prole Road and Ōmokoroa Road in the short term.
