# 8.1 APPOINTMENT OF INDEPENDENT HEARINGS COMMISSIONER - OMANAWA FALLS PROJECT

Cr Murray-Benge declared a <u>Conflict of Interest</u>, noting that she was a Submitter to the Omanawa Falls Project consent application process. She took no part in the discussion or voting thereon.

The Environmental Consents Manager introduced the report.

#### Key points:

- The application had been 'Limited Notified' to the public. Twelve Submissions were received, triggering the requirement for a hearing. Of those submissions; six were in support; four were opposed, and two were neutral.
- This Council, and the BOP Regional Council (BOPRC) would hold a joint hearing to determine the matter, potentially in the New Year.
- Council had a Joint Hearings Protocol with the BOPRC, who intended to appoint an Independent Commissioner, although there had been no indication a Commissioner for BOPRC had been appointed yet.
- On discussion with the District Plan Committee Chairperson, it was determined that appointing an Independent Commissioner would be appropriate to determine the matter for this Council.

# Staff responses to questions:

- The Joint Hearings Protocol allowed for flexibility. It was understood that BOPRC appointed Commissioners for all its hearings. In that regard, the potential for it to appoint Councillors to the joint panel was highly unlikely.
- The potential composition of the joint hearings had been discussed with the Chairperson. Discussion had centred around the fact that there was much interest in the outcome for a number of Councillors. Of note, it would be highly unusual for Council to appoint a single Councillor to such a joint panel.

The Chairperson advised that, when determining whether this Council should appoint a Commissioner, BOPRC had already signalled they would, therefore, it was appropriate for this Council to do so for the joint hearing.
